The Austrian Civil Aviation Authority presents its highest consideration to the Department of State Policy in Civil Aviation of the Ministry of Transport of the Russian Federation and would like to make reference to the prospective introduction of a Leasing Article within the bilateral framework.

Due to an internal restructuring, Austrian Airlines would like to use leased aircraft and crew from Tyrolean, which is a 100% subsidiary company of Austrian Airlines, starting on 1 July 2012. Therefore, and according to the letter of the Federal Air Transport Agency of the Ministry of Transport of the Russian Federation dated 20 June 2012 the bilateral framework would have to be adapted.

In this respect, the Austrian Civil Aviation Authority would suggestincluding the Leasing provision as attached in the Annex to this letter into the bilateral framework via the exchange of letters between the respective authorities.
