

**RECORD OF DISCUSSION BETWEEN
THE AERONAUTICAL AUTHORITY OF THE REPUBLIC OF TURKEY AND
THE AERONAUTICAL AUTHORITY OF RUSSIAN FEDERATION**

Delegations representing the Aeronautical Authorities of the Republic of Turkey and of the Russian Federation -hereinafter referred to as "The Delegations"- have met in Colombo on 5th of December, 2017 to discuss air transport issues of mutual interest and update the operational arrangements.

The discussions were held in a friendly and cordial atmosphere.
The composition of the two Delegations is attached as Attachment A.
The following understanding was reached between the Delegations:

CAPACITY AND FREQUENCY

- Passenger

Turkish Delegation proposed to increase the number of the frequencies of the scheduled passenger services for the defined routes and specify additional destination points in Russian Federation for the designated airlines of Turkey. Turkish Delegation also requested to add the temporary destination points to the route schedule. As response, Russian Delegation proposed to discuss the above mentioned requests of Turkish side in the next round of negotiations in early 2018 in Turkey.

- Cargo

Russian Delegation stated that they want to add Tel Aviv as beyond point with 5th freedom traffic right for the operations of Russian Air Carriers for their cargo operations. As response, Turkish Delegation replied that they will evaluate the mentioned request for cargo operations of Russian Air Carrier and the request will be discussed in the next round of negotiations in Turkey in early 2018.


